MESSAGE FROM CITY ATTORNEY BARBARA J. PARKER



My Office continued to advocate forcefully to protect and advance the rights of all Oakland residents throughout Fiscal Year (sometimes "FY") 2016-17.

We prosecuted abusive landlords to protect and uphold tenants' rights, and we continued lawsuits against Monsanto for contaminating Oakland waterways and against Wells Fargo bank, our country's largest mortgage lender, for predatory and racially discriminatory mortgage lending practices against African American and Hispanic borrowers.

We represented the City in court and provided critical legal advice to City leaders regarding every aspect of the City laws, services, policies and programs.

We reduced the amount the City paid to resolve claims and lawsuits by millions of dollars. In fact, this FY's total payouts were the lowest amount since the City Attorney began issuing Annual Reports in FY 2001-02. We brought in more than \$2.36 million in settlements and other payments to the City's general fund to be used for critical services like police, fire, parks and roads. And we kept outside counsel costs low by strategically using our staff resources.

In accord with our mission to protect the rights and interests of all Oaklanders, we joined other municipalities, counties and states in challenging the current federal administration's unconstitutional, discriminatory and inhumane actions.

The City Attorney has published an Annual Report every year since Fiscal Year ("FY") 2000-01 to give residents, businesses and taxpayers a transparent and comprehensive accounting of the work our Office performs on their behalf.

Like prior annual reports, the FY 2016-17 Annual Report details financial results, litigation trends, advisory work, affirmative litigation and special initiatives that the Office undertook during the fiscal year beginning on July 1, 2016 and ending June 30, 2017.

I look forward to hearing your questions and comments about this report and about the services we provide.

Mission of the City Attorney's Office

The City Attorney's Office plays an integral and often behind-the-scenes role in City government.

The City Attorney defends Oakland's interests and resources in court and initiates legal action to secure justice and protect the rights of Oakland residents and taxpayers. We draft and review ordinances and resolutions and sponsor legislation, often with members of the City Council and/or the Mayor. We aggressively and strategically negotiate major agreements and contracts and help to shape Oakland's policies. And we provide expert legal advice to City leaders and officials including the Mayor, City Council, City Auditor, City Administrator and City departments, boards and commissions.

Our mission is to provide the highest quality of legal services, promote open government and accountability to the residents of Oakland and apply the law in an innovative and community-oriented manner to advance Oaklanders' rights and improve the quality of life in Oakland neighborhoods.

We accomplish this mission by constantly pursuing excellence, professionalism and a workforce that values and reflects Oakland's diversity.

TOP PRIORITIES

- Continue to provide the highest quality of legal services to City officials, departments, boards and commissions by negotiating, drafting and reviewing agreements, legislation, regulations, policies and procedures and helping to shape viable, legally sound policies, programs and services for the City.
- Aggressively defend Oakland's interests and resources in court and in administrative proceedings and initiate legal action and other initiatives to protect and enhance the rights, interests and quality of life of our community.
- Uphold transparent, honest and fair government by enforcing the Public Records Act, Sunshine Ordinance and other open government laws, and by ensuring that City officials and employees know and play by the same rules.
- Advocate for equal opportunity, diversity, justice and a level playing field in our community and beyond.
- Continue to explore and identify ways to provide expert and professional legal services in the most efficient and cost-effective manner possible.
- Maintain a staff of highly-qualified and dedicated attorneys and support staff with extensive knowledge of the City of Oakland and municipal law in order to meet demands more efficiently and effectively.

Office Profile

During this fiscal year, the City Attorney's Office announced a major reorganization to enhance, develop and make affirmative litigation and other efforts to secure economic, environmental and social justice, civil rights, equity and fighting discrimination a top priority, and to enhance and more effectively and efficiently coordinate the Office's handling of labor and employment matters, including but not limited to police department policies/procedures and personnel/discipline cases.

Prior to this fiscal year, the City Attorney's Office was divided into two legal divisions: the Advisory Division headed by Chief Assistant City Attorney Doryanna Moreno, and the Litigation Division headed by Chief Assistant City Attorney Otis McGee.

The August 2017 reorganization added two new divisions to the City Attorney's Office: the Labor & Employment Division headed by Special Counsel Ryan Richardson and the Affirmative Litigation, Innovation & Enforcement Division headed by Special Counsel Maria Bee.

The Office also includes an Operations Team headed by Legal Administrative Services Manager Dara Wiseman and an Executive Team headed by City Attorney Barbara J. Parker.

■ EXECUTIVE TEAM

The Executive Team includes the City Attorney, Chief Assistant City Attorney (Advisory Division), Chief Assistant City Attorney (Litigation Division), Special Counsel (Labor & Employment Division), Special Counsel (Affirmative Litigation, Innovation & Enforcement Division), the Legal Administrative Services Manager (Operations) and the Chief of Staff (Policy, Open Government & Communications).

ADVISORY DIVISION

The Advisory Division provides legal services that address the full spectrum of municipal affairs. Examples include drafting legislation and contracts, negotiating real estate transactions and providing advice on housing and economic development projects, labor and employment matters, land use, finance, retirement, benefits, elections, constitutional law, ethics, conflicts of interest and other matters.

■ LITIGATION DIVISION

The Litigation Division advocates for the City's interests in claims and lawsuits that are filed against or on behalf of the City, its officers, employees and agencies. Lawsuits are litigated in the state and federal trial and appellate courts. Examples include high value personal injury cases, complex civil rights actions, personnel disputes, eminent domain actions, breach of contract, challenges to constitutionality of Oakland's laws, policies and procedures and inverse condemnation cases. Litigators take an aggressive and strategic approach to manage liability and limit the City's financial exposure. As public servants we advocate for a fair and just resolution when the City's liability is clear.

■ LABOR & EMPLOYMENT DIVISION

The Labor & Employment Division advises the City on labor and employment matters with a special focus on advice and counsel to the Oakland Police Department. The division includes Departmental Counsel for the Oakland Police Department to enhance coordination of the City Attorney's handling of police matters, including police department policies and personnel/discipline cases.


■ AFFIRMATIVE LITIGATION, INNOVATION & **ENFORCEMENT DIVISION**

The Affirmative Litigation, Innovation & Enforcement Division includes affirmative litigation, community lawyering, civil rights enforcement, code enforcement, general public safety and the Neighborhood Law Corps (NLC). The NLC is an award-winning program that in recent years has focused on preventing illegal dumping, suing abusive landlords who violate the rights of Oakland tenants and shutting down hotels, massage parlors and other businesses that collude in human trafficking and the sexual exploitation of minors. In addition to the NLC, the division includes two units: the General Code Enforcement & Public Safety Unit and the Community Lawyering & Civil Rights Unit (CLCR), which focuses on proactive lawsuits and other actions to protect and advance the rights and interests of Oakland residents with a goal of economic, environmental and social justice.

■ OPERATIONS GROUP

The Operations Group administers the budget, personnel and support services of the City Attorney's Office. The group includes administrative and information technology staff, legal secretaries, paralegals and an Open Government Coordinator.

REFLECTING OAKLAND'S DIVERSITY

The Oakland City Attorney's Office continues to be one of the most, if not the most, diverse legal teams in the country. Our 76-member staff is approximately 62% women and 66% people of color. As of the date of this report, our team of dedicated professionals included:

- 43 attorneys: City Attorney, two Chief Assistant City Attorneys, three Special Counsel, seven Supervising Deputy City Attorneys, 25 Deputy City Attorneys and five Neighborhood Law Corps attorneys.
- Approximately 54% of our attorneys are people of color and 62% of our attorneys are women.
- 33 support staff: three Executive Assistants, eight Paralegals, nine Legal Assistants (commonly referred to as legal secretaries), four Operations Managers, three Public Service Representatives, two Information Technology ("IT") staff, one Claims Investigator, one Analyst, One Accountant and an Open Government Coordinator.



SUMMARY

The City Attorney's Office strives to safeguard taxpayer dollars by providing the highest quality legal service to the City and its residents in the most efficient and efficacious manner.

The City Attorney's operating budget was \$15.12 million this year, the same total as the previous fiscal year.

The City spent an additional \$1.36 million on litigation expenses (court fees, retention of experts, arbitration expenses, etc.).

As detailed below, the total cost of outside counsel was \$4.09 million. This amount is 40 percent lower than the high point in FY 2012-13, before the Council and Mayor began to restore some of the 33 staff (19 attorneys and 14 support staff positions) that the City Council cut from the Office's budget over the decade beginning in FY 2003-04.

The amount the City pays to resolve claims and lawsuits, including settlements and judgments, varies from year to year depending on the types of cases that are filed against the City and the types of cases the City initiates. In FY 2016-17, payouts for claims and lawsuits filed against the City totaled \$2.39 million, a significant decrease from previous years, when the City paid settlements in high-liability cases involving police use of force and accidents involving infrastructure and City vehicles. The total amount of payouts for claims and lawsuits is 83 percent lower than it was two years ago (FY 2012-13), when total payments reached an all-time high of \$14.58 million.

Note: The total numbers in this Annual Report may include final tallies from the City's accounting office that were not available when we published the previous year's Annual Report. In some cases, totals from previous years have been updated to reflect more recent information.

REVENUE RECOVERED

The Oakland City Attorney's Office seeks to recover the highest possible amount of revenues to fund City services and programs and implement City policies. We join class action lawsuits or other litigation when Oakland's interests are jeopardized, and we pursue affirmative litigation to protect the economic interests and quality of life of the community. Our Office recovered revenues, including attorney's fees and costs, civil penalties, payments for damages, settlement payments and other payments on behalf of the City.

This year, the City Attorney's Office recovered more than \$2.36 million for the City, money that helps to pay for vital services such as libraries, police and fire, road repair and parks.

HIGHLIGHTS

Outer Harbor Terminal, LLC U.S. Bankruptcy Court Case No. 16-10283 (LSS)

The City Attorney's Office obtained \$850,000 for the City in a bankruptcy court settlement with Outer Harbor Terminal, LLC, a company that leased Port of Oakland property and managed shipping and other operations there. Outer Harbor Terminal, also known as Ports America Outer Harbor Terminal, filed for bankruptcy in February 2016. The company had a 50-year lease with the Port of Oakland to run Port operations. In November 2016, the U.S. Bankruptcy Court for the District of Delaware approved the payment of \$850,000 to the City of Oakland to settle a City claim regarding transfer tax (a tax the City imposes when a party sells or conveys an equivalent property interest in real estate).

Green Therapy/Kim's Spa Alameda County Superior Court Case Numbers RG15768389 and RG15781010

As of the date of this report, the City Attorney's Neighborhood Law Corps has sued and closed a total of 13 massage parlors and spas where police investigations found evidence of trafficking and prostitution, including Green Therapy on Hegenberger Road and Kim's Spa on 13th Street. These 13 cases also have resulted in settlements and fines against defendants totaling at least \$518,500, plus several permanent injunctions barring defendants from owning or operating a massage or spa business in Oakland. Most of that total will be reflected in next year's Annual Report. Tragically, human trafficking and the sexual exploitation of women and girls remains is an ongoing crisis in Oakland. Disrupting and shutting down the human trafficking industry continues to be a top priority of the City Attorney's Office. The Neighborhood Law Corps is continuing its work with Oakland police to investigate and prosecute businesses that cater to or profit from the sexual exploitation of women and girls in our community, and we continue to exercise the City Attorney's independent power under state law to shut down those businesses and hold operators/owners accountable.

Oakland v. AMBAC Financial Group Inc. San Francisco Superior Court Case No. CGC 08-479241

In 2008, the City Attorney filed this lawsuit against major bond insurance companies. The lawsuit was handled by outside counsel (Renne Sloan Holtzman & Sakai in San Francisco and Cotchett Pitre & McCarthy in Burlingame) on a contingency fee basis meaning the law firm doesn't receive any fees unless the City prevails. Those companies charged California cities and other public agencies millions of dollars to guarantee their debts, while at the same time concealing financial shenanigans that made it impossible for the firms to provide the services they were paid to provide. In FY 2016-17, Ambac Assurance Corporation paid \$754,888 to settle Oakland's lawsuit. The total recovery to date is \$781,718.

Outside Counsel Costs

PROTOCOL

Like other cities and counties, Oakland hires outside counsel to handle legal work (1) when the Office lacks the specific expertise that is needed, (2) when the City, a City board or commission, an employee, the City Attorney or another City official has a conflict of interest, (3) when a particular matter requires dedication of resources that are not available in house, such as a major class action suit that demands full time work of one or more attorneys, or a major case that requires dedication of a team of attorneys and (4) when the Office lacks in-house capacity to handle the volume of legal work.

In FY 2011-12, shortly after the Council appointed Barbara J. Parker as City Attorney to complete the term of the City's first elected City Attorney, the City Attorney established a Request for Qualifications ("RFQ") process to make the hiring of outside counsel more competitive, open and transparent. The City Attorney's Office maintains a database of pre-qualified firms with expertise in a wide range of areas of law. A firm's diversity and whether it is based in Oakland are factors in selection of outside counsel. This is a standing RFQ. In addition, from time to time, our Office issues RFQs for particular matters.

BACKGROUND

Contracting out legal services to more expensive outside attorneys and firms increases the total cost of legal services and reduces the money available for other vital City services such as police, libraries, sidewalks and streets.

Over the ten-year period beginning in FY 2003, the OCA lost more than one-third of its staff (19 attorneys and 14 support staff) due to the City Council's budget cuts.

In that same time period, outside counsel costs rose from \$1.45 million to a highest level of \$6.83 million in FY 2012-13, an increase of about 370 percent.

Because of the loss of in-house staff, the City Attorney had to contract out a far greater amount of Charter-mandated legal work to more expensive and less efficient outside counsel. In fact, the higher cost of outside counsel far outweighed the savings realized by cutting in-house legal staff. For example, during the four-year period of FY 2007-08 through FY 2010-11, staff cuts reduced the Office's budget by \$3 million. However, during that same period the cost of outside counsel rose from \$1.74 million to \$6.18 million, an increase of \$4.44 million. In other words, Oakland spent more on outside counsel than it saved by cutting in-house legal staff.

The City Council has restored some of the positions our Office lost to budget cuts during the decade beginning in FY 2003-04. The new positions made it possible for the City Attorney's Office to handle work in-house that otherwise would have been contracted out to outside counsel at a much higher cost to the City.

As a result, the cost of outside counsel fell to \$4.09 million in FY 2016-17 from a high of \$6.83 million in FY 2012-13, the year before the Council began to restore positions to the City Attorney's Office. The savings in outside counsel has more than paid for the annual cost of the restored positions.

As we discuss further below, depending upon lawsuits that are filed against the City and catastrophic events, outside counsel costs vary from year-to-year. However, it is well-established that in-house counsel are able to more efficiently and effectively handle the day-to-day work of the City at a lower cost than outside counsel.

COST ANALYSIS

The need for outside counsel varies from year-to-year, sometimes dramatically, depending upon the number of in-house staff in the City Attorney's Office and the volume, complexity and types of legal issues facing the City.

The Council's restoration of in-house positions to the City Attorney's Office in the last two fiscal years was a factor in keeping the total cost of outside counsel relatively low this year.

However, the cost of outside counsel will vary each year depending on the types and number of legal issues and matters before the City, and time constraints given the City Attorney's in-house resources. As the above cost analysis shows, restoring additional staff in future years will decrease outside counsel expenses.

A caveat is in order. In some years the necessity of hiring outside counsel for major cases will increase the City's outside counsel costs. Examples of such cases that were filed against the City or filed on behalf of the City in FY 2016-17 are: (1) the Ghost Ship cases filed on behalf of 51 plaintiffs to date regarding the December 2, 2016 warehouse fire in the Fruitvale District; (2) the Oakland Bulk and Oversize Terminal's ("OBOT") lawsuit challenging the City's coal ban at the former Oakland Army Base, and; (3) the City's lawsuit against California Waste Solutions to enforce the City's exclusive franchise agreement with CWS for recycling. We anticipate that outside counsel costs for these three lawsuits will be significant and will be reflected in next fiscal year's outside counsel costs.

Note: The cost of outside counsel spiked in FY 2005-06 due to one case (Pacific Renaissance). In this case, the City Council hired outside counsel against the recommendation of the City Attorney, and outside counsel expenses for the case ultimately totaled \$3.26 million in that fiscal year. The outside counsel costs for that year would have been in line with prior and subsequent years without this expenditure.

COST ANALYSIS: OUTSIDE COUNSEL FOR CITY-APPROVED PROJECTS

In FY 2016-17, the City spent a total of \$4.09 million on outside legal services. However, some of those costs were incurred as part of City projects such as the development of the former Oakland Army Base, and were paid with funds approved for those projects. This year, the City spent approximately \$970,000 on outside legal services for City-approved projects. These costs were paid by City-budgeted project funds.




Figure 2: Outside Counsel Timeline

The total cost of outside counsel who were retained by the City Attorney and paid from the City's Self Insurance Liability Fund (Fund 1100) was \$3.12 million (red graph below). The total cost of outside counsel including payments from Fund 1100 and budgeted project funds was \$4.09 million (blue graph below).




Figure 3: Total Outside Counsel Costs v. Costs Paid by the Self Insurance Liability Fund (Fund 1100)

Payouts

TOTALS

Payouts include settlements of claims, settlements of lawsuits and judgments against the City.

This fiscal year, payouts for claims and lawsuits filed against the City totaled \$2.93 million, the lowest annual total since the City Attorney's Office issued its first annual report in FY 2000-01. In previous years, major settlements in high-liability cases involving vehicle accidents, employment matters, police conduct and infrastructure problems drove up the total amount of payouts. This year, only three settlements exceeded \$100,000, and no settlements exceeded \$1 million (see Table 3 below). By comparison, last year FY2015-16) 12 settlements exceeded \$100,000.

Note: To be consistent with previous Annual Reports, the chart below tracks total payouts, including payments made by the City and the City's insurance carrier's (CSAC Excess Insurance Authority) separate payments. CSAC made no payments during this fiscal year. City pays the first \$3 million for an incident and CSAC pays amounts in excess of \$3 million up to \$25 million per incident.

IMPORTANT INFORMATION ABOUT PAYOUTS

The total amount of payouts varies from year to year depending on many factors, including the types and complexity of claims and lawsuits filed against the City.

The City Attorney's Office works strategically and aggressively to limit financial exposure. When liability is clear, the City seeks to protect taxpayer resources by settling for the lowest possible amount, thereby avoiding the high risk of an adverse jury verdict that would cost taxpayers a much greater amount.

The City Attorney's Office provides legal advice and analysis of potential settlements to the City Council. The Council has reserved authority to approve all settlements exceeding \$25,000.

The City's annual premium for general liability insurance in FY 2015-16 was \$3,723,363.

MAJOR PAYOUTS

This year, settlement of a wrongful death lawsuit accounted for one third of the total payouts for the year. This year, there were only three settlements for amounts over \$100,000, and no settlements for over \$1 million.

PAYOUTS BY CATEGORY

Payouts fell dramatically in every area this year, especially in the category "City Vehicle Accidents." Last year, total payouts in that category were high due to the \$2.75 million settlement of a wrongful death lawsuit involving a police vehicle accident. This year, there were no payouts over \$100,000 in this category.

Litigation Division

The Litigation Division advocates for the City's interests in claims and lawsuits filed against or on behalf of the City, its officers, employees and agencies. Lawsuits are litigated in the state or federal court systems. Examples include high value personal injury cases, complex civil rights actions, personnel disputes, eminent domain actions and inverse condemnation cases.

Litigators take an aggressive and strategic approach to limit the City's financial exposure and to managing liability at the claims stage to limit expensive lawsuits. Only a very small percentage of claims evolve into lawsuits (only 1.4 percent in FY 2016-17), underscoring the effectiveness of this strategy.

CLAIMS FILED

Claims fall into four categories: municipal infrastructure (streets, sewers and sidewalks), police matters (conduct, towing, jail and property damage), city vehicle accidents and "other."

The City received 756 claims this year, a steep rise from last year's total of 583. Most of that increase was in the category of Municipal Infrastructure, which includes "trip and fall" claims, potholes, etc. Additional risk management, including increased resources dedicated to fixing infrastructure problems, likely would reduce the number of claims, high liability lawsuits and payouts in this area.

CLAIMS RESOLVED

We resolved a total of 528 claims in FY 2016-17. This year 84 percent of claims were resolved with no payment of money whatsoever, up from 80 percent last year. Less than one percent of claims resolved this year resulted in a payout of more than \$25,000.




Figure 5: Claims Resolved Over 5 Years

CLAIMS THAT EVOLVE INTO LAWSUITS

The City Attorney's Office aggressively manages liability at the claims stage to limit expensive lawsuits. When liability is clear, we seek to settle claims early to avoid the higher cost of litigation. The vast majority of claims never evolve into lawsuits, underscoring the effectiveness of this strategy. This year, only 1.4 percent of claims turned into lawsuits.




Figure 6: Claims that Evolved into Lawsuits by Year of Incident

LAWSUITS FILED AGAINST THE CITY

Lawsuits primarily arise in the following categories: municipal infrastructure, police matters, City vehicle accidents, personnel/labor, complex contracts and "other."

In FY 2016-17, plaintiffs filed 149 lawsuits against the City of Oakland. Notably, lawsuits filed against the City were down in every category except Police Conduct Matters, which increased slightly from the previous year.

Note: In this table, "Police Conduct Matters" do not include police-related vehicle accidents or personnel/labor matters.

LAWSUITS RESULTS

When lawsuits are filed, our litigators work aggressively and strategically to protect taxpayer resources, reduce litigation costs and limit potential exposure by filing motions to dismiss defendants and causes of action, thereby narrowing the scope of defense. When liability is clear, we seek to resolve the matter early to limit the cost to taxpayers.

This year, the City Attorney's Office resolved 113 lawsuits. The large majority (58 percent) were resolved with no payment of money whatsoever. Only 2 percent of the lawsuits resolved this year resulted in a payout of more than \$100,000.




Figure 7: Lawsuits Results

DEFENSE VERDICTS

The City prevailed in a number of high profile cases in FY 2016-17. Examples include:

Brown v. City of Oakland Alameda County Superior Court Case No. RG09455950

In FY 2016-17, the City Attorney's Office litigated this case regarding a dispute over a contract awarded more than 10 years ago for general contracting services. In 2006, the plaintiff, Mr. Brown, was a general contractor who received a one-year contract to perform various "as needed" construction projects for the City. Mr. Brown sued the City in 2009, claiming that the City failed to pay all he was owed. He also sued a former City employee, alleging that the employee made deceptive statements that caused Mr. Brown to underestimate costs of the construction projects and eventually led to the loss of his construction business. The trial court jury rejected Mr. Brown's claim. Mr. Brown appealed, and in July 2017 the California Court of Appeal rejected Mr. Brown's appeal in its entirety.

Kavanagh v. City of Oakland Alameda County Superior Court Case No. RG16808127

Mr. Kavanagh alleged that he was riding his motorcycle when he hit a pothole on the off-ramp of Highway 24 at the Broadway exit. As a result of the accident, Mr. Kavanagh suffered major injuries. He filed a lawsuit against the City and the State of California (CalTrans) seeking compensatory and general damages. The City moved for summary judgment on Mr. Kavanagh's claims asserting that the City could not be held liable because the pothole was not located on the City's property. CalTrans acknowledged that it owned the property where the accident occurred. But CalTrans attempted to persuade the court that the City "controlled" the off-ramp and therefore was liable for his injuries. After briefing and oral argument, the Court dismissed the case against the City in 2017.

Advisory Division

The Advisory Division provides legal services that address the full spectrum of municipal affairs. Examples include drafting legislation and contracts; negotiating complex contracts in matters including information technology, energy systems, garbage and cable franchises; providing advice on housing and economic development projects; providing advice on labor and employment matters and union negotiations; representing and defending the City in arbitrations challenging disciplinary actions against City employees and interpretations of labor agreements; negotiating real estate transactions; issuing municipal bonds; providing advice about finance, bonds, retirement, benefits, elections, ethics and conflicts of interest; providing advice on police, fire and emergency services policies, procedures and practices; defending the City's ordinances against challenges in court; and initiating legal proceedings to address public nuisance/quality of life issues in Oakland neighborhoods.

In FY 2016-17, the Advisory Division was comprised of three main units. Examples of practice areas and responsibilities of each unit are included in Tables 8-10.

Labor & Employment Division

In the FY 2016-17 Fiscal Year, City Attorney Barbara Parker announced a major reorganization of the City Attorney's Office, which included the creation of a Labor & Employment Division to enhance and further prioritize the Office's handling of labor & employment matters, with a special focus on advice and counsel to the Oakland Police Department.

Previously, the City Attorney's Office had two divisions – the Advisory and Litigation divisions. The new Labor & Employment Division has allowed the Office to focus and coordinate our resources in this critical area. The Division includes Departmental Counsel for the Oakland Police Department to enhance the Office's handling of police matters, including police department policies and personnel/discipline cases. Special Counsel Ryan Richardson heads this division.

LABOR & EMPLOYMENT DIVISION HIGHLIGHTS:

- Reviewed staff reports, resolutions and legislation related to personnel issues.
- Assisted and advised in the drafting and submittal, as well as initial implementation, of ballot Measure LL, which was approved by over 83% of Oakland's voters and established a Police Commission ("Commission") to oversee OPD's policies and procedures and a Community Police Review Agency ("Agency") to investigate complaints of police misconduct and recommend discipline.
- Helped implement and interpret Oakland's minimum wage and sick leave initiative (Measure FF).
- Advised City Administration and numerous City Departments (including Police, Fire, Public Works, Employee Relations, Human Resources, and Equal Opportunity Programs Division) on various personnel and labor issues, including leaves of absence, disability accommodations, workplace threats, drug testing, and workplace discrimination.
- Advised OPD Internal Affairs on investigations into police misconduct and reviewed resulting investigative reports, including an in-depth and interactive training for IAD investigators on important aspects of the investigation process.
- Developed and administered multiple trainings for the managers and commanders at both OPD and OFD who handle those department's Skelly hearings.
- Attended Skelly due process hearings on behalf of the City in cases involving serious employee misconduct and advised Skelly officers regarding their recommendations.
- Provided personnel advice to Fire Chief at biweekly meetings and advised the Chief on responses to union grievances.
- Advised City Administration and City Departments on "meet and confer" issues, participated in resulting bargaining sessions, and drafted resulting polices and agreements.

- Managed and resolved disputes with various unions over employee discipline and contract (MOU) interpretation by negotiating settlements and by representing the City at binding, labor arbitration hearings.
- Represented and defended the City before the California's Public Employment Relation Board.
- Represented and defended the City before Oakland's Civil Service Board.
- Reviewed, edited and approved numerous contracts for professional services.
- Advised City Administration and City Departments on numerous Public Records Act requests.

Affirmative Litigation, Innovation & Enforcement Division

As part of the Office's reorganization in August 2016, City Attorney Parker created a new division to make a top priority of affirmative litigation and other actions and initiatives to secure justice and equity for all Oakland residents and workers regardless of their race, gender, sexual orientation, immigration status or economic status. Our affirmative efforts also include actions to protect rights that are being undercut and decimated on a daily basis by the current federal administration.

The Affirmative Litigation, Innovation & Enforcement Division includes three units: the Community Lawyering & Civil Rights Unit (CLCR), the General Public Safety and Code Enforcement Unit (GPSCE) and the Neighborhood Law Corps (NLC).

COMMUNITY LAWYERING & CIVIL RIGHTS UNIT

City Attorney Parker created the CLCR in 2016 to focus and streamline affirmative litigation and other initiatives to secure social, economic and environmental justice and equity for all Oakland residents. The CLCR filed several lawsuits during this fiscal year to prevent abuse of tenants, uphold Oakland's Minimum Wage Ordinance and protect the rights of Oaklanders.

City of Oakland v. Kilpatrick, Alameda County Superior Court Case No. RG16820040

In this case, the CLCR joined a coalition of civil rights organizations and attorneys in suing the owners of a Single Room Occupancy ("SRO") building in Oakland's Chinatown. The lawsuit alleged that the owners have made living conditions unbearable in an effort to force tenants out, renovate the building and make way for higher rents. The owners (1) demolished kitchens and bathrooms, gutting them and rendering them unusable for months, (2) confiscated and discarded tenants' property, and (3) generally harassed tenants to get them to leave. The owners, who purchased the property in 2015, have publicly expressed the hope that remodeling the building will draw a "new demographic" of tenants including tech workers, and will allow the owners to rent the SROs with in-unit bathrooms at a premium. We are pleased to report that the court ordered the owners to fix the facilities at the property and remove surveillance cameras that violated the residents' privacy rights.

Oakland v. Jaber, Alameda County Superior Court Case No. RG16829447

In January 2017, the CLCR and the Neighborhood Law Corps secured an injunction against the owners of a Fruitvale area apartment building where for years tenants have complained that they had no heat, no working smoke detectors, bedbug and cockroach infestations, faulty electrical wiring and other habitability problems, including a fire in July 2016 that caused extensive damage to several units. After buying the Fruitvale Avenue property in 2007, the owners have consistently failed to address tenants' complaints about illegal and inhumane conditions. The City's lawsuit includes a declaration from a family that slept in a closet and on their kitchen floor for nearly a year and a half to avoid being bitten by bedbugs.

Oakland v. Choice Hotels International, Alameda County Superior Court Case No. RG17847671

Also in January 2017, the CLCR partnered with Centro Legal de la Raza to sue an international hotel chain and its affiliate in Oakland for systematically violating state labor laws and Oakland's minimum wage ordinance by refusing to pay overtime, failing to provide sick leave and engaging in other illegal conduct towards employees. This was the City's first lawsuit under the minimum wage ordinance Oakland voters passed in November 2014. The lawsuit is ongoing at the time of this report.

NEIGHBORHOOD LAW CORPS

The Neighborhood Law Corps (NLC), which celebrated its 15th anniversary this year, is a unit of recent law school graduates who tackle quality of life issues and public nuisances including human trafficking, illegal dumping and violations of tenants' rights.

Illegal Dumping Enforcement Program

This year, the City of Oakland continued its campaign to go after individuals who are responsible for one of the worst sources of civic blight in Oakland: illegal dumping.

The Illegal Dumping Enforcement Action initiative – a joint effort by Oakland City Attorney Barbara Parker, the Public Works Agency and the City Administrator's Office - uses photos, videos and other evidence submitted by members of the public to track down illegal dumpers and make them pay for disrespecting Oakland's residents, businesses and taxpayers.

Dumping old mattresses, furniture, construction debris, garbage and other items on sidewalks, in parks and under freeways is a major source of blight in neighborhoods across Oakland. An increasing number of Oakland citizens, many using camera phones, are taking photos and videos of illegal dumping incidents and reporting violators to the Public Works Agency using the Agency's on line service request page or the SeeClickFix mobile application for Oakland.

The NLC uses that evidence to build cases against dumpers, and the City Administrator's Office issues citations. To date the City has issued hundreds of thousands of dollars in fines against illegal dumpers.

Lawsuit against Landlords who Demolished Tenant's Home

In FY 2016-17, the NLC prosecuted a lawsuit against the owners of a property near Lake Merritt who illegally demolished their tenant's home while he was living in it. The lawsuit charged the owners with violating Oakland's Tenant Protection Ordinance and California's Bane Act, harassing, threatening and unlawfully evicting tenant Jahahara Alkebulan-Ma'at, who lived at the property at 369 MacArthur Boulevard for 22 years.

Mr. Alkebulan-Ma'at was disabled and lived at the property with his minor son. The owners filed an unlawful detainer action in January 2017, and began shutting off all utilities. By mid-March, Mr. Alkebulan-Ma'at and his son had no heat, no hot water, no electricity, no cable and no internet.

On March 16, the owners changed the locks. Mr. Alkebulan-Ma'at's medication was locked in his home. On the same day, one of the owners sent him an e-mail threatening that there would be "consequences" if he "set foot on the premises again." The next day, the owners began demolition of the unit while Mr. Alkebulan-Ma'at's property was still inside. Mr. Alkebulan-Ma'at slept in the partially demolished unit for two nights, and on both nights, one of the owners showed up in person and made threats against his safety.

The owners' campaign of threats and harassment was especially outrageous in a city that is struggling with a historic housing crisis.

NLC Secures Settlement to Redevelop Former Sausage Factory

In March 2015, the NLC sued the owners of the properties on Adeline and 28th streets after the City issued at least 26 citations for graffiti, illegal dumping, overgrown vegetation and other public nuisances associated with the properties.

The owners purchased the abandoned Sausage Co. building and the adjacent lots in 2002. On their watch the properties fell into disrepair and became a magnet for blight and crime in the neighborhood.

In addition to the 26 citations the City issued for violations of its blight ordinance, the City's Public Works Agency also issued no less than 167 work orders to clean up graffiti and illegal dumping associated with the property. The owners' failure to maintain the property and provide security measures allowed homeless encampments, squatters and crime including burglaries, shootings, car break-ins and vandalism.

Under the settlement which was executed on July 1, 2017 the owners will immediately repair holes in the fence surrounding the property, remove all trash and debris and secure the building. The owners also must move forward on redevelopment of a commercial property on the site, and must hire an independent monitor to oversee compliance.

Prosecuting Businesses that Act as Fronts for Prostitution and Human Trafficking Human trafficking and the sexual exploitation of women and girls unfortunately is a crisis in Oakland.

In the two years prior to the date of this report, the NLC has closed 14 massage parlors and spas where police investigations found evidence of trafficking and prostitution: Green Therapy on Hegenberger Road, Kim's Spa on 13th Street, Telegraph Massage Center on Telegraph Avenue, Oakland Therapeutic Massage Center on Webster Street, 888 Spa on 98th Avenue, Yan Lan on 13th Street, TJ Therapy on Telegraph Avenue, Oak Spa on Edgewater Drive, Yan Yan on 38th Avenue, Evergreen Spa on Telegraph Avenue, Lee Spa on Grand Avenue, Ace/Top Spa on Pendleton Way, Airport Massage on Oakport Street and Oriental Wellness Center on Franklin Street. Most of those closures were the result of lawsuits filed by the NLC.

These cases also have resulted in settlements and fines against defendants totaling at least \$531,549, plus several permanent injunctions barring defendants from owning or operating a massage or spa business in Oakland.

Police say the female workers at illicit massage parlors and spas often appear to be victims of human trafficking. Many come from China or Korea on travel or work visas, and then remain in the U.S. as "employees" of brothels after their visas lapse. They often speak little or no English and often do not have access to their own passports. Some have no passports or any other form of identification. They often are moved from location to location in Oakland and across the state and refuse to act as witnesses.

Disrupting and shutting down the human trafficking industry continues to be a top priority for my Office.

Special Programs, Initiatives & Litigation

OAKLAND FIGHTS BACK

In this fiscal year, one of the major priorities of the City Attorney's Office was to fight back against unconstitutional, discriminatory and inhumane actions of the current federal administration. In the last 11 months, we have signed onto a number of amicus ("friendof-the-court") briefs supporting challenges by other cities, counties and to unconstitutional and other violations of law by the current occupant of the White House and his henchmen and henchwomen. These federal actions would deprive Oakland of federal grant dollars to which it is entitled, target Oakland and its residents for deportation and attempt to coerce Oakland and other municipalities and counties into enforcing federal law, which is the federal government's obligation.

OPEN GOVERNMENT PROGRAM

The City Attorney's Open Government Program enforces transparency and accountability in City government. The program provides technical and legal assistance to City departments regarding public records requests. It also oversees compliance and provides trainings about the California Public Records Act, Sunshine Ordinance and Brown Act. The Open Government Coordinator addresses constituent issues and helps facilitate responses to requestors seeking public records and documents. In FY 2016-17, the Open Government Coordinator reviewed, responded to and facilitated more than 1,000 public records requests involving thousands of pages of documents.

Conclusion

It is my distinct honor and pleasure to serve as City Attorney for our enlightened, progressive and innovative City. Oakland recognizes and champions the use of the law as a powerful and effective tool to improve our community, and to empower, protect and advance the interests of all Oaklanders. I and my team are dedicated to vigorously and astutely defending Oakland's policies, programs and laws in court, and to initiating legal action and other initiatives to uphold the rights, economic interests and protect and enhance the quality of life of our residents. We also are constantly searching for ways to address the crises we face, with a the current occupant of the White House, with the crisis of affordable housing in Oakland and the Bay Area which has led to a homelessness crisis and with the systemic racism that permeates our society and all of our institutions. Statistics show that approximately 50 percent of the homeless people in Oakland are African American and more than 80 percent were residents of Alameda County before they became homeless. I am committed to developing and implementing laws and policies to achieve equity and a level playing field. Our faithfulness to accountability, fiscal responsibility and fair, honest, open, non-discriminatory and equitable City practices continues to be the framework that guides our mission. I am grateful to the Oakland electorate for giving me the opportunity to serve the City I love.

Barbara Parker is the City Attorney for Oakland, California. An Oakland resident for nearly four decades, Parker is an advocate for civil rights, women's empowerment and children's issues.

In July 2011, the City Council appointed Parker to complete the term of the first elected Oakland City Attorney. In November 2012, Parker, Oakland voters elected her to a four-year term as Oakland's second elected City Attorney. In November 2016 Oakland voters elected Parker to a second four-year term. She is the first and only African American woman elected to city-wide office in Oakland.

In an award-winning legal career spanning more than four decades, Parker has developed extensive expertise as an attorney in the private sector and at all levels of government, including work in the private sector for two major law firms and two major corporations, more than five years as an Assistant United States Attorney for the Northern District of California, and more than 10 years as Chief Assistant City Attorney (second in command in the Oakland City Attorney's Office).

Parker was born and raised in Seattle, Washington, where her parents migrated to escape the grinding poverty and legalized oppression of sharecropping in the rural, segregated South. Parker resides in Oakland's Haddon Hill neighborhood near Lake Merritt. She is the proud parent of Savannah Parker, a 2012 graduate of Spelman College, and bursting-with-pride grandparent of Samuel Koda Clement.
